## Treasurer Report:

Stan is very sick and hasn't been able to turn over books to Rob. \$16,741.40 in both accounts. Jeff may write a check to two people we owe money to. We will try again to get together to have signatures switched.

## Legal:

Chris says the filling status of the lake should have been completed a while ago. The account of the water has been passed around. The only entity to comment has been the town of Monument. However, it should all be approved by the end of this month. There is no new status about the "naturalness" of the lake. We should know by July 11.

CWCB and DOW, want to meet with us. This meeting has been switched to July 29. An exploratory type of meeting that shows they are interested in us. We want co-sponsorship from either.

They can help us through appropriating a water right so that we can move water. In the future if we need too. We really want them to restore flow to the lake. We want to get the RR involved in this too.

Benches are \$1500 with a \$100 maintenance fee.

<u>GOCO</u>: Amy has lots of feelers out for donations. She has signed us up for Donation Match. Still waiting to here back from Home Depot on two fronts.

<u>MLB</u>: Chris spent some Tri Lakes Little League. They want to be involved in our project because they want a "home" to call their own. Chris wants to do a fundraiser

in maybe September. It has been decided that movie night will be Sept 12<sup>th</sup>. Chris will put together an estimate for developing a plan for landscaping the field. He has a friend that can put some numbers together. Major League Baseball has a grant called Baseball Tomorrow Fund. We are in the process of applying for this.

Progressive Dinner: Tuesday, July 28. Jeff says \$50 per person and the restaurants will keep \$25 for their costs. Jeff will have more information next week about how it will "progress". 20/30 people will be the limit. This will be a 5 course dinner. Taste of PL August 28. Limit 400 people.
